

WWII HRS Scholarship 2018

In 2010 the membership approved the creation of an HRS scholarship. The effort behind the scholarship was twofold. The primary goal is to assist the younger members of our organization in their pursuit of higher education. Secondly, we desire to grow interest in historical reenacting as an educational endeavor which is part of the mission of our Society. The scholarship will be awarded to a full time undergraduate or graduate student. The preferred majors are history, museum studies, or archeology however all HRS member students are encouraged to apply. The award can be used towards tuition or books and will be paid to the student's college or university to be credited to their account. Note that any family or relations of any board of directors or staff of the WWII HRS will be ineligible for this award.

Please send the applications to the WWII HRS Vice President. The amount of the award is \$500.

Eligibility:

- 1. Must be a current member of the WWII HRS in good standing in at least their second year of membership.
- 2. Must provide proof of being a full-time student, undergraduate or graduate, at an accredited college or university.
- 3. Must demonstrate a minimum GPA of 2.75.
- 4. Must currently be a history or associated major, however if there is not any history or associated major that apply then all majors are eligible.
- 5. Must not have been awarded a previous WWII HRS scholarship.

Requirements:

- 1. The student should write a 500-word essay describing their qualifications and justification for receiving the HRS scholarship including the student's future plans in reenacting.
- 2. A letter of recommendation from the student's unit commander. If the student is the unit commander, then another unit commander acquainted with the student can supply the recommendation.
- 3. Unofficial transcripts or a letter from the student's college or university stating the student's current major and GPA.
- 4. A recent picture in WWII uniform of the student.

Deadline: July 1 **Notification**: August 1

An article highlighting the student will be published in the Society publication, The Edge, after the scholarship is awarded.

Review:

A committee consisting of an Allied, an Axis, and a Commonwealth WWII HRS member, preferably involved in education, will review and give recommendation to the Society board of directors for awarding the scholarship based on the submitted applications.



The Browning 1917 Heavy Machine Gun By Kerwin Law

Just after the United States entered WWI, it began looking for an improved machine gun to replace the relative few it possessed. These various designs would include the 1895 Colt, 1904 Maxim, 1909 Benet-Mercie, 1914 Hotchkiss, 1915 Vickers and the Lewis machine gun. With the water-cooled machine guns ruling the roost on the European battlefields so well, the time had come to find an American made counterpart. Fortunately, the search wouldn't take too long. They would have to look no further than John Browning. If you factor in all his other brilliant gun designs, it should come as no surprise that his latest weapon proved to be more than up to the task. As would be the case with his BAR, John Browning would accept millions less when he sold the government the rights to his design. He said "If that suits Uncle Sam, it's alright with me". How's that for patriotism?



When official testing was being done at the Springfield Armory in mid-1917, one of his water-cooled machine guns fired 20,000 rounds with no parts breakages and only 3 stoppages. These few stoppages were thought to be the fault of the ammunition. Another 20,000 or so were fired with only one part failure and a few more stoppages, of which were blamed on belt loading. Then, another test gun Browning brought was fired for 48 minutes straight with no malfunctions whatsoever. Well now, I think we have a winner here. Soon after, the Browning Machine Gun, US Caliber .30, Model of 1917 was adopted. An interesting note, the machine gun was even demonstrated to the public just outside of Washington DC in early 1918. Don't you just love the good old days?



The next task was to get them into production and fast. Well, production did happen, but not exactly fast. New England Westinghouse, Remington and Colt would be selected to manufacture the 1917 Browning MG and as with many weapons rushed into production, teething problems existed. These problems included faulty heat treating, leaky water jackets and bad barrels. As these problems were sorted out, the three companies would go on to make 68,000 before the war would end. (I would like to point out that in my research there was not a consensus of production totals, so I have used the prevailing numbers throughout) Of this total, it's believed that only about 30,000 actually made it to Europe by 1918. Unfortunately, of these, only about 1,100 were able to make it to the front lines and into combat. Although this was a limited test sample, it was felt to be a sufficient number to prove that the design was robust and reliable. It seems Uncle Sam was indeed satisfied with his new water-cooled machine gun.





In the interwar years, modifications were made, such as receiver reinforcement and improvements to the belt feeding system. The several upgrades approved were not done on a wide scale though. That is until the Rock Island Arsenal was given the task of implementing the desired changes to several thousand of them. At some point a few other government arsenals pitched in, which left almost no 1917 Brownings in original configuration. Because of the many changes that were ultimately made, the military felt that a new model designation was warranted. So, in late 1939, the M1917A1 Browning Machine Gun was adopted. In addition to these modified guns, from 1942 to 1945 the Rock Island Arsenal would go on to manufacture nearly 54,000 new M1917A1 MGs for the war effort. Those, coupled with WWI production and the few thousand produced immediately after WWI to finish out contracts, would put well over 125,000 1917/1917A1 MGs into the US military's hands by 1945.

As with the Thompson Submachine Gun and Browning's own BAR, it would take the second World War for the M1917A1 MG to really prove its value. In its intended role as a static defense weapon, it was outstanding. Whether it was in North Africa, Europe or the Pacific campaign it just ran and ran. Probably the biggest knock against the M1917A1 was the fact that it was a heavy beast. It was 100+ pounds with gun, mount, water and accessories. The weight it seems wasn't perceived to be as much of a problem in the static trench warfare of WWI, as it would be in the next world war. I'm sure moving this thing up hills and such in combat was no fun, but there had to be some comfort in knowing you could fire it for days in an effort to repel attacks on your position. (For some heroics involving the M1917A1 look up John Basilone) To help alleviate portability issues, it would be mounted on vehicles and even moved with mules and handcarts.



The M1917A1 would again be relied upon in Korea, where its sustained fire capabilities would prove invaluable against the human wave attacks our troops encountered. In the extreme cold of Korea, one problem with a water-cooled MG was encountered, and that is obtaining an adequate water supply. It was soon learned that the human by product that's used to make yellow snow, could also keep your Browning running cool and happy. While Korea would mark the last time the US would heavily rely on the water cooled M1917A1 MG in combat, it would not completely disappear from inventories for many years to come. The much lighter air-cooled M-60 with its quick-change barrel would officially take over as our standard machine gun in 1958, thus helping to bring about the end of a long and successful career for another Browning weapon design.

"First and foremost, the event kicks off with a tour of the National Churchill Museum. For those who arrive for our preliminary, we will depart from Auto World Museum at 10:30 AM, this allows time for people to arrive on Friday morning of Sept. 28, 2018. It is a short drive from Auto World down Westminster Avenue to the Churchill Memorial located at Westminster College in Fulton in central Missouri. We will begin with a luncheon at the college's Backer Dining Hall and what a place it is, it reminds me of St. George's Chapel at Windsor Castle, minus the regalia. During my recon of the museum last October, I was walked through our projected tour that begin at the Church of Saint Mary, the Virgin, Aldermanbury. This 16th-century church, which is now a functioning place of worship, was destroyed during the London Blitz of 1940. Designed by renowned architect, Christopher Wren, it was moved to Fulton, in honor of Winston Churchill's visit to Westminster College in 1946. We entered the church as the organist was delivering a recital just as those who participate in this convoy will experience. Next, we descended into Winston's Inner-Sanctum, where you will be immersed into the life and times of Sir Winston Churchill after a reception of tea and "bickies" (cookies to you non-Anglophiles). To conclude, we will have a group photo-op at the staircase overlooked by a statue of Winston beside a section of the Berlin Wall. Remounting, we will return to our host hotel to freshen up before our evening meal. Tiffany Genaro of Baymont Inn has reserved a black of twenty rooms for us that vary from basic rooms to jacuzzi rooms, all at a discounted rate. For those looking for posher accommodations, the Loganberry Inn B&B is where Margaret Thatcher and Nobel Peace Prize winner, Les Walesa have stayed. The B&B is located a short two-minute walk from the Churchill Museum. Joe Kalal is planning on attending as Winston Churchill and will be arriving in my Canadian LaSalle Staff Car.

Approval of Agenda

RK motioned to approve the agenda as sent out. WM seconded. Agenda was approved by BOD vote.

Reading of December Meeting Minutes

The December Minutes were read by WM. RK motioned that the December Minutes be approved as read. That was seconded by CV. The December Minutes, as read, were approved by BOD vote.

Officer Reports: Vice President: New Charters: NO new Charters for 2018

Probationary charters: End of Probation Period Report:

2nd Jaeger Battalion (Payton)(Finnish) - CB did receive the end of the year report from 2nd Finnish Battalion. It was posted a week or so ago and is being currently voted on. CB asked if we should wait for a few more votes on the Unit before approving them as a Unit, but a motion was made by CB, seconded by DS. A roll call vote was taken and the 2nd Jaeger Battalion was approved as a Full membership.

Matt Iverson's 3rd Division, 2nd Company (Finnish) This Unit has not responded to CB's request for a year-end Report. CB will contact him again for the Report. This will be tabled until next month.

FeldLazarette Grosdeutschland This Unit has also not submitted their end of year Report and will be tabled until next month.

First Co, 1st Battalion, Jaeger Div 28 This Unit has also not submitted their end of year Report and will be tabled until next month.

CB further reported that there are currently 106 chartered or pending chartered Units. 8 of them are on Probation, 1 is waiting for a vote to be put on probation and there were 4 new Charters adopted by the HRS in 2017 and there were two Charters disbanded in 2017.

The US Army WWII Chaplain: Part 4 By LTC (ret) Tim. A. Scherrer

The US Army Chaplain's Unit Equipment

The US Army chaplain had a variety of equipment to get the job done. Below is a picture is the list of unit equipment that was issued to the chaplain section, which consisted of the chaplain and chaplain's assistant. This part will cover the field equipment issued to chaplains that supported deployed units.

Chaplains' Outfit (Christian-Faith, Stock No. 36-O-800 and Jewish-Faith, Stock No. 36-O-810) consisted of following items:

• Chests, Container, Hymnal, Music-Edition – Stock No. 36-C-1287 (later replaced by Chest, Steel Container, Hymnal, Music-Edition, Stock No. 36-C-1295)

• Desks, Field (Empty), Fiber, Headquarters – Stock No. 26-D-140 (later replaced by Desk, Field, M-1945, Stock No. 26-D-158)

- Flags, Chaplains', Christian-Faith Stock No. 5-F-980
- Flags, Chaplains', Jewish-Faith Stock No. 5-F-985

• Music Books, Hymnal, Chaplains' Outfit, Song-and-

Service – Stock No. 36-M-657 (150 copies)



Desks, Field (Empty), Fiber, Headquarters – Stock No. 26-D-140 (later replaced by Desk, Field, M-1945, Stock No. 26-D-158)









The chaplain section was authorized the largest of the field desks of the three standard types. The desk was 29 ³/₄" wide, 23 ³/₄ high and 16" deep. They weighed 78 pounds empty. Hymnals were carried in a separate crate. The reason chaplain needed the largest size field desk escapes me! The chaplain probably needed a desk that could carry a typewriter for correspondence as well as a place to carry some religious reference books, and a small amount of records. The M1945 replacement is what reenactors commonly think of as the postwar field desk.





Chests, Container, Hymnal, Music-Edition – Stock No. 36-C-1287 (later replaced by Chest, Steel Container, Hymnal, Music-Edition, Stock No. 36-C-1295)









The Hymnal Chest is one of the most rare original items to acquire.. Only a couple chests were known to exist with another chest recently discovered, but I will come back to that. The hymnal chest is a wood and steel reinforced crate thatis 28" long by 11" wide by 11"tall. The crate held 152 Song and Service Book for Ship and Field, Army and Navy hymnals, in 19 stacks of 8. The case weighed over 40 lbs when full. .Dunavin Woodsmith is now making a fabulous reproduction of this rare crate.



The Song and Service Book for Ship and Field is just as it's title describes, a book ofstandard religious services and song to be used by chaplains of all denominations. The books are 8.5"by 6" by $\frac{1}{2}$ " thick and had 194 double sided pages. There was a red edition for the Army and a Blue edition for the Navy. Most are gold embossed on the cover, but some editions are just blackened in the stamping. The crate contained 150 standard hymnal books and two specially marked books. One was marked *Pulpit* and the other *Organ* in the lower right corner of the cover. Unmarked books are easily found for about \$6-8.

I discovered theanother hymnal chest at the Missouri Museum of Military History on the 13th of October 2017. I had looked at their chaplain display. While leaving when I spied a familiar looking crate in a signal corps display. I got the curator and we opened it up to discover it was a hymnal chest. It is being moved to the chaplain section soon. It was marked for the 942nd Medical Clearing Company.








Flags, Chaplains', Christian-Faith – Stock No. 5-F-980 and Flags, Chaplains', Jewish-Faith – Stock No. 5-F-985







There are two sizes of chaplain's flags that are seen. The first is the chapel flag, which is quite large. The second is the chaplain's flag. Both are identocal in color, markings and only differ in size. The color on the flags is a blue similar to infantry blue or the field on a US flag. The branch insignia is in white with white trim.

The chapel flag is 4' 5" by 5'6" with white fringe. It is to always be displayed with theUS flag. The chaplain flag, 2' x 3', is used to mark the location of a service, be it a tent, jeep hood, building entrance or a field location. Chaplains were issued both the Christianand Jewish flag, since they maycondicting services any denomination. The Christian flag had a latin cross and the Jewish flag has the tablet or Decalogue with roman numberals I-X to symbolize the commandments. The Jewish flag is very rare to find. The Roman numerals versus the Hebrew numbers also changed with the insignia changed.









Chaplain's Brassard

Introduced in 1944, the chaplain's arm band was blue with a white cross on it. It was very similar to the Geneva Convention white arm band with red cross, except in a different color. While this was authorized, it's use is difficult to document. The white brassard with the red cross was easier to see and the only time a chaplain would need to wear a barassard was when they were operating under fire. Since all chaplains were trained in medical tasks and were helping wounded soldiers on the battlefield, I suspect most chaplains wore the white arm band and even medical marked helmets in combat.



• Organs, Folding, Chaplains' – Stock No. 36-O-580 The pump organ, also known as the reed organ, melodeon or harmonium has been around since the 1800s. They were used in churches without electrical power, revivals, missionaries and mining camps They operate by having air flow past a piece of metal that vibrates. The metal vibrating piece is called a reed. The air flow is caused by foot petals opening and closing bellows, much like when an accordion is opened and closed. A pump organ weighs about 30 lbs., and is about 3-4' x 18" x 18".



The Army started acquiring organs for chaplains during WWI. The WWI models varied but the Liberty Pipetone Folding Organ was most prevelant, although Estey and Billhorns may have been used.





The Army needed considerably more pipe organs for the large expansion of the chaplain corps during WWII. The Estey organ was smaller and lighter than the Liberty. It had a 4 octive keyboard versus 5 octaves on the Liberty. Being more compact and lighter, the Etsey was in use as early as the the 1930s by the Army. While the Estey was the standard organ, other organs in the inventory were also used. The phrase "use until supplies are exhausted" applies with all things Army.



The Estey Field Organ pictured above is located at the Missouri Museum of Military History in Jefferson City, MO. It was pulled out of the attic of an armory in thepast decade. It is black in color on the case and the interior has been painted a muted red matching the Army Service and Songbook cover color. The serial number dates it to the late 1930s. It has a silver plated US tag on the back side. That is the only indicator that it was a military chaplain's organ byond the model type.





Many of the surviving organs have been painted OD color. A survey of WWII pictures indicate that the organs were mostly unpainted i with their original black cases, like the Missouri museum organ. There is a natrual tendancy in the military to paint everything OD. The organ being black or OD probably had not real impact on it's use. A chaplain would not set up a field service in an area where a black or OD organ may make the difference of attracting enemy fire! I suspect some of them were originally painted OD and some have been restored after the war to be OD. These were still in use in the 1950s, according to a chaplain frield of mine that served in 1955. He was issued one for field services, and used it often.

A second model organ was issued in 1945, which is similar to the WWII design. In Vietnam the Lo Duca organ was also used. The rain and humidty of Vietnam was damaging to the organs. The military changed to an electric organ or cassette recorded music by the mid point of the Vietnam War.



Many people assume any folding pipe organ was a chaplain's organ. A guess is about 5,000 were acquired by the Army for field use among the nearly 9,000 chaplains. Many chaplains assigned to fixed bases and facilities didn't need a field organ since their church had pianos or organs inside them.

The original cost of the organs is difficult to find, but using an advertisement from earlier, I was able to transpose the cost to 2015 dollars, which is \$2,700. In WWII dollars, that is \$200 (about the cost of about four M-1 Garand rifles). Today they can be found for about \$100-\$1,000, based upon the condition. There is an Estey organ club that has a website and lots of additional information.


